

# **Topics in Trauma**



### 2025 Trauma Conference

## Sept. 19, 2025

This conference is a one-day educational opportunity to provide current issues and trends related to the trauma patient.

#### **Objectives**

- Learners will identify the four facets of the Lethal Trauma Diamond and explain how ionized calcium loss contributes to worsening trauma outcomes.
- **2.** Learners will describe when and how to replace calcium in trauma patients based online access and patient physiology.
- **3.** Identify three characteristics that place the geriatric population at risk for trauma.
- **4.** Recall three evidence-based treatments/ interventions for geriatric patients experiencing trauma.
- **5.** Discuss clinical implications of recent position statements focused on the prehospital care of patients presenting with hemorrhagic shock and circulatory arrest.
- **6.** Define circulatory arrest and identify evidence-based strategies linked to survival.
- 7. Understand the unique challenges involved in each

- step of the trauma management process.
- **8.** Learn to recognize, diagnose and treat penetrating neck injuries.
- **9.** Learn about treatment and extrication of patients during extended operations.
- **10.** Become familiar with low-frequency, high-acuity calls that are not commonly witnessed in our area.
- **11.** Compare and contrast SALT, START and JUMP START triage methodologies, including indications, limitations and patient outcomes.
- **12.** Identify key strategies and "secrets" of effective triage during high-stress incidents, with a focus on decision-making under pressure.
- **13.** Review crucial aspects of successful pelvic binder placement and understand which fracture patterns are contraindicated for binder placement.
- **14.** Control of hemorrhagic shock in unstable pelvic fractures.

#### Who should attend

Nurses, pre-hospital clinicians and all healthcare providers involved in the care of trauma patients.
